Overview

This Privacy Policy ("Privacy Policy") describes how we, Imarticus Learning Pvt. Ltd. Purpose

Personally Identifiable Information

 - Contact Information, such as name, email address, mailing address, IP address, geographic location, or phone number
 - Unique Identifiers, such as username, or password
 - Name and e-mail address when you provide feedback from the Service(s)
Users may visit our Website anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us.

Non-Personal Information:

We capture some non-personal information in our logs. The information includes:
